PM said we had invested money into the buggy and the roller door to assist in the set up of junior and senior competition.

PM acknowledged Callum Elks received the Caren Friend award, which is a \$2000 scholarship to go to tournaments and ref on behalf of MWTA. This helped him get to NYC QLD in 2023.

RH asked why the spending on JSC had almost doubled, PM answered that this would be due to the cancellation of 2022 JSC. Same question for Vawdon Cup, and the reason being was due to Covid-19 cancellation. Same goes for Senior Winter Comp.

Other General Business

MS brought up the lights in front of Field 4 as there is currently an eagle nesting with chicks, however the bulbs are out. GK stated that council refuse to touch the light pole with the endangered species in it but stated that he knows that the visibility is bad.

MS also brought up the size of the fields, especially for the premier league teams, as the fields are 55m, not 70m as the traditional field is. GK reasoned that the new line markers (Sportsfield Line Marking - SFLM) came on board after the year that was rained out, and they line with a GPS, however the grounds were wet and previously un-marked. Council originally marked the fields properly, and SFLM marked the fields as the GPS did the very first year. GK stated that the fields should be adjusted to full size fields after Christmas. MS asked if we have any other full field allocations, GK responded with F14 and F15.

RH asked if the juniors played on full fields. GK said the U7s and U9s play on half fields, whereas the juniors play on full fields, however we have had to shorten them due to the size of Nolan Reserve. We could have 13 bigger fields, and have to turn away teams, or have 15 slightly shorter fields and be able to have as many teams as we do.

PC asked about having a congratulations to Lara Long at SSC due to the hard work and effort she has put in over the years. Executive Committee agreed that SSC was the best way to do it as most of the people she worked with would be present, and she is no longer attending Friday Junior Comp.

It is with great pleasure that I present a summary of the 2023/24 financial year to the members of the Manly Warringah Touch Association Incorporated (MWTa).

In line with good governance the Audited Financial Statements and Auditor's Report for the Year Ended 31 March 2024 are included as Appendix 1 - MWTa Financial Report.

Strategic Financial Intent

The MWTa Executive Committee's ongoing strategic financial intent is to maintain leadership in all aspects of best practice financial management to respect and deliver our Economic Mission:

To preserve the ongoing economic viability of the organisation, while ensuring the financial accessibility of the sport of Touch Football remains.

Performance Driven Financial Outcomes

The MWTa Accounts are prepared in such a manner that each of the Junior and Senior, Summer and Winter competitions, State Cups and Vawdon Cup representative competitions can be easily analysed.

The MWTa Executive Committee has implemented and continues to review strategies to ensure that the organisation remains in a position financially and resourcefully to respond quickly to all influences and economic pressures.

Financial Highlights

The results for 2023/24 reflect MWTa's operations in the reporting year, which accounts for the delivery of the sport of touch football for both recreational and representative players in the Manly Warringah region of Sydney.

Operating Result

MWTA achieved a net loss of \$10,972 for the financial year ended 31 March 2024. This result is appropriate for our local community-based sporting association and Not for Profit Organisation when considering before non-cash depreciation of \$14,211 the result was a profit.

During the 12-month financial period our cash increased by \$5,374. The cash reserves we hold will enable us to uphold our commitment to give back to our members via investment in several programs, initiatives and capital expenditures that benefit all MWTA members in future years.

Analysis of Reported Results

During the financial period the MWTA Executive Committee continued to closely monitor expenditures and investigate cost reductions.

The result was due to the committee aiming to break even for the year which was achieved with the addback of the depreciation of \$14,211. Junior competition registration fees were increased slightly and members were asked to also pay for their singlet if required. This gave members the opportunity to save money by reusing their singlet rather than being required to purchase another one. TFA introduced a levy of \$22 for all players that was paid directly to TFA so the registration fees for senior and lower competitions reduced as we did not collect the funds and then pay to TFA.

Commitments

MWTA has no significant liabilities. There are currently no commitments to purchase or lease equipment or property. There are also no unresolved issues that may create a liability for MWTA in the future.

Significant Events

There were no significant events in the state of affairs of MWTA during the financial year.

Historical Financial Synopsis

The Executive Committee continues to compare year to year performance. This provides the Executive Committee consistency and surety in financial decision making and projections.

Accounting Practices

MWTA is a NSW Tier 1 Incorporated Association and is required to have its accounts audited. The financial statements must, at a minimum, satisfy the requirements set out in Class Order No. 11/01 Financial Reporting Requirements.

The 2023/24 audit was conducted by Mr Jack McCann (BA CA CPA JP Director). Mr McCann is an ASIC registered Auditor as well as a licensed Financial Advisor and Tax Agent. I recommend that Mr McCann be appointed auditor for the 2024/25 financial year.

MWTA uses the Xero accounting software program, which is a cloud-based package that enables the MWTA Executive to review the accounts on an ongoing basis. MWTA engages a bookkeeper from time to time to assist with financial matters and advice.

Summary

The MWTA Executive Committee will continue to manage member funds in a diligent and professional manner and provide such stewardship in order to promote and foster the sport of Touch Football for both recreational and representative players in the Manly Warringah area.

MWTA is budgeting to break even for the 2024/25 financial period.

MWTA is currently in a very stable and strong financial position with no change to this expected.

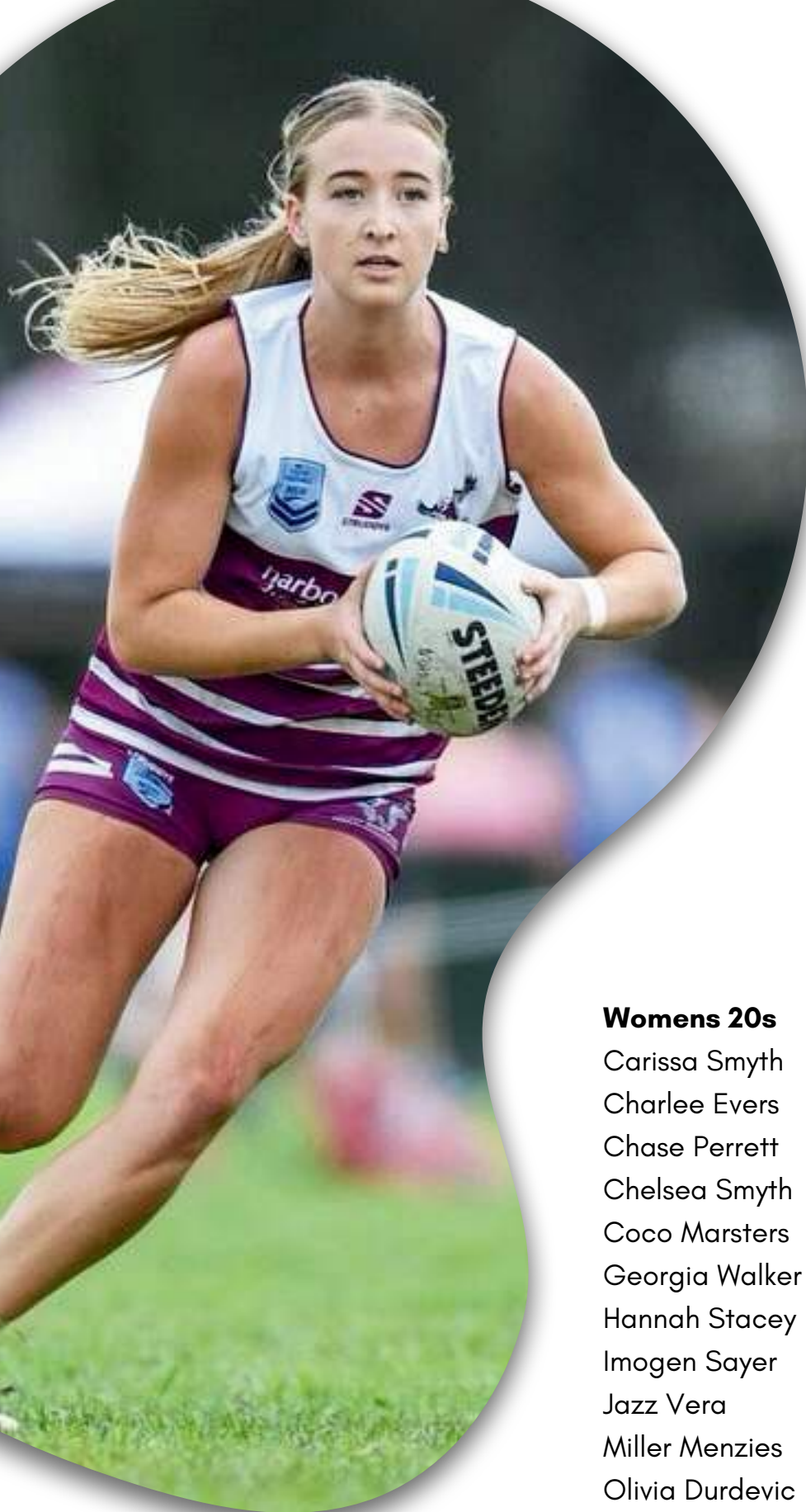



1. STATEMENT OF ACCOUNTING POLICIES

(a) Basis of Accounting
